Indemnity Agreement
and Guaranty

I, _____ (defendant), and _____ (indemnitor), in consideration of Cheri Collins and/or David Collins and/or Seneca Insurance Company acting and being obligated as surety on a bail bond for the defendant, as principal, in the amount of \$ _____, do guarantee the payment of said bond to surety in the event of forfeiture by the above named principal. I specifically waive notice of acceptance of this guaranty, acknowledge myself as fully bound by all provisions of the above stated bail bond, and expressly agree to pay, upon demand, any amount owing, not to exceed the amount of forfeiture ordered thereunder, and I do hereby agree to indemnify and hold harmless Cheri Collins and/or David Collins and/or Seneca Insurance Company for such amount he or she is required to pay upon such forfeiture. This agreement is voided upon termination of liability on the bail bond as provided by North Carolina General Statute 58-71 and North Carolina Administrative Code 0500. I/we agree that surety may obtain credit information from any source it may deem necessary. It has also been agreed by all parties involved that a faxed copy of this agreement is to be treated the same as an original.

Terms and Conditions:

It is agreed and understood that the happening of any one of the following events shall constitute a breach of the principals obligations to said surety and surety shall have the right to apprehend, arrest, and surrender principal without giving any refund of the premium whatsoever.

- (1) Willfully fails to pay the premium to the surety or willfully fails to make a premium payment under the agreement specified in G.S. 58-71-167.
- (2) Changes his or her address without notifying the surety before the address change.
- (3) Physically hides from the surety.
- (4) Leaves the State without the permission of the surety.
- (5) Violates any order of the court.
- (6) Fails to disclose information or provides false information regarding any failure to appear in court, any previous felony convictions within the past 10 years, or any charges pending in any State or federal court.
- (7) Knowingly provides the surety with incorrect personal identification, or uses a false name or alias.
